WHOLE OF GOVERNMENT ACCOUNTS 2008-09

CENTRAL GOVERNMENT BODIES

This Appendix sets out the central government bodies that are included within the Whole of Government Account. The bodies are in the following three groups:

- those that are designated by HM Treasury. The bodies are in England, Wales and Northern Ireland;
- bodies within Northern Ireland that are designated by the Northern Ireland Department of Finance and Personnel; and
- bodies in Scotland that are required to provide data to the Scottish Executive.

DCM 01/09 applies to the bodies in England, Wales and Northern Ireland that are designated by HM Treasury and to the Scottish bodies that are required to provide WGA data by the Scottish Government. The Northern Ireland Department of Finance and Personnel issues separate guidance to those bodies it has designated.

This Appendix does not include funds or pension schemes that are administered by departments and other CGA entities since the designation of a body includes the activities of the body designated and all the funds it operates or manages.
